

Justin Salmen is 39 years old and incarcerated in California, USA

Hello, my name is Justin Salmen. I am seeking help due to corruption and injustice done to me and multiple other people by an LA District Attorney. I was born and raised in Long Beach, and I'm currently serving a life sentence after DA Chelsea Blatt perjured the court to convict me of murder. My trial had many important irregularities and I write to you now asking for help in my ongoing fight for justice.

I was forced by the California parole board to live in a reentry program by the CA parole board called AB109 with a convicted murderer and documented white supremacist not in the AB109 program, who lived in my room as the "maintenance man." This was despite me specifically being in protective custody from white supremacists (since I grew up in foster care and had an African American mother as a white man myself). This white supremacist had Aryan Brotherhood tattoos, which are only earned by murdering African Americans and any enemies to the Aryan Brotherhood—people like me.

One night I had to defend myself against this white supremacist murderer while he threatened my life, and after that I began to experience many miscarriages of justice. The facts of the night I defended myself were severely distorted by the DA so she could argue for a premeditated homicide, when in reality I was only defending myself in that moment. The judge refused my defense attorney pictures of the tattoos, therefore removing my ability to testify had I left the white supremacist alive he would go get more white supremacists. Also, the DA convinced the judge to not allow me to testify about me having African American family growing up in foster care, which was the entire basis of me being in protective custody from white supremacists, and specifically the threats from the white supremacist that ultimately led up to the night I defended myself. Other important parts of my story were also omitted, the judge and DA said in the interest of time, even though leaving this out clearly influenced the jury's understanding of my case and the outcome I received.

Now I am in possession of many different types of evidence of the DA's perjury, which ultimately led me to being framed for first degree murder when the homicide was both justifiable and excusable, and the worst the state should have accused me of was imperfect self defense due to placing me in dangerous and illegal circumstances against my will.

I need your help, and want someone to alert BLM type organizations and other media resources to expose this miscarriage of justice as soon as possible. I am losing my appeal because the Federal Judge Jean Rosenbluth is helping the state's representatives (DA Chelsea Blatt) perjure the court to keep me convicted and the lies DA Blatt told are upheld to conceal all of this. 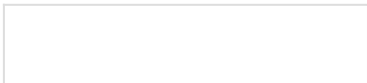
