Profiles with photos get more mail. If you don't have a photo at this time, you can post your profile and send your photo later. Your photo (or artwork) will be returned to you along with a printout of your profile. Only you can be featured in the photo. If someone else appears in the photo, please identify yourself. We will remove the other person(s) without damaging the photo. Original artwork (no larger than 8 1/2" x 11") may be substituted for a photo. Photos that generate the best response rate are those that highlight your accomplishments while in or out of prison or showcase you spending time productively. If neither of these is available, a simple smiling photo is also good.

Please refrain from mentioning anyone by name in your profile. Sexual language is prohibited. No business may be conducted through your profile. Profiles must be submitted in English. No copyrighted work will be accepted. Any profile we feel inappropriately represents us will be returned and fully refunded prior to processing.

Please be sure to specifically state what type of legal aid you seek. (e.g., DNA testing, legal research). Be as specific as possible, and to keep the cost of the Legal Profile low, please make good use of your words. You are trying to inspire people's compassion while presenting a strong legal case.

If you currently have access to an attorney, we recommend asking him/her to review your Legal Profile prior to placement on WriteAPrisoner.com. We are not legal experts, and we are unable to give legal advice.
